### A. Financial Officer's Report

### B. Chief's Report

Chief Lockhart discussed Department activity for October. The list below highlights this month's Chief's Report:

- Harley Drawing was on October 27<sup>th</sup> and was won by Rick Swan of Chandler. Chief added that Larry Waltemeyer had reduced the price of the Harley to the Firebelles by a \$1000 allowing a profit of \$2000 for the organization. Also, Chief said that Mr. Swan was very pleased with the Harley.
- Karen Thornton added that the CC HOA Halloween Party was on October 27<sup>th</sup> and was a success with (+-) sixty kids in attendance.

- Steve asked Chief if there were any contact with the Gila County Sheriff's Office regarding the two, ongoing cases. Chief replied there had been none.

# Item #4: Discussion and possible action regarding Chief Lockhart's two other bids from auditors.

This Item was also incorporated in discussion and possible action of **Item #3**. In addition, during Board discussion of **Item #3**, Deborah recognized the following Members of the Public:

- James Oliver commented re: bid from Saunders Company, LTD., (as possible auditor replacing Kay Green).
- Karen Thornton replied to Board that Kay Green was physically present at Station 51 for two days and was available for Board Members' possible comments and questions. None showed.
- Debbie Richardson commented that in her experience running a business, this time of year is much too late to look at changing to a new auditor.

# Item #5: Discussion and possible action regarding purchasing a replacement apparatus for Engine 531.

Board Member Jeff Daniels brought to the attention of the other Board Members that this was Chief Lockhart's decision based on his M.O.U. Chief said he would keep the Board apprised of his progress. Chief did state he was trying to stay around a cost of \$125 thousand for a replacement apparatus.

# Item #6: Discussion and possible action regarding using Brindle Mountain Fire Apparatus to sell Rescue 511.

Chief described Brindle Mountain Fire Apparatus similar to a realtor or bank; Brindle Mountain Fire Apparatus will list the Department's apparatus to the appropriate audience. If sold by this organization, there will be a 10% charge; if sold outright, there is no charge. Rescue 511 has been appraised at \$75,000. Chief will keep the board informed of the progress with the listing and future sale of Rescue 511.

## Item #7: Discussion and possible action regarding Policy 10.14 Residency Requirements.

After Board discussion of corrections to **Policy 10.14**, Chief will make changes, revise wording, and bring to Board for further discussion and possible action during the December Board Meeting. No Board action required.

# Item #8: Discussion and possible action regarding Policy 30.07 Work Schedule, (Administrative).

Brief Board discussion took place. After revising wording, Chief will also return **Policy 30.07** to Board for discussion and possible action during the December Board Meeting. No Board action required.
